All vendor space numbers will be assigned the morning of the event.





Terms/Information:

All requests for an exhibitor space must be held with a credit card to ensure the space is held. Full payment is required for all vendors within 2 weeks of event. Booth locations will be determined after receipt of completed application and full payment.

Spaces are assigned onsite.

Cancellations: 2 weeks prior to event incurs a 50% cancellation fee. 1 week prior to event incurs a 75% cancellation fee.
